### Agenda item 4. Winterization Draft Guidelines Presentation and Partner Discussion/Questions

The Draft of Ukraine Shelter/NFI Cluster Winterisation Recommendations 2016-2017 was presented for final review during the meeting. It consists of main part and 3 Annexes:

- **Annex I Lessons Learned from 2015-2016** describes consultations with Shelter/NFI partners and government stakeholders;
- **Annex II Lessons Learned from 2015-2016** includes experience from last year and prescribes specific recommendations and response to advanced planning, stock for emergency referral, NFIs, fuel, monetization;
- **Annex III Price of electricity and calculation** provides information of price of electricity depending on the category of affected population.

The Draft of Ukraine Shelter/NFI Cluster Winterisation Recommendations 2016-2017 includes categories of affected population and their needs formulated in 3 sub-themes, which were presented in Northern Donbas Sub-National Cluster Winterisation Recommendations 2015-2016. They are:

- 1) personal items
- 2) fuel and heating
- 3) shelter insulation.

After extensive field consultation, a **4<sup>th</sup> sub-theme** related to infrastructure and to the living of individuals in social institutions was added.

It was also noted that in HRP 2016 activities of insulation and shelter repairs were separated. Following field consultation, it is obvious that for 2017 prices and repairs activities should be updated and merged together.

Cluster Coordinator stated that Shelter Cluster and partners should also work with donors and development actors to facilitate complimentary relief and recovery efforts given that the situation in Northern Donbas GCA is more advanced than in previous winter, while humanitarian needs were very acute in front line and NGCA communities. The point is to specify a wide group, generalize the affected population and then agencies according to their mandate will decide what category is more vulnerable. Moreover, in the perspective of decreasing availability of funds, the donor community will probably want to know where funds, which will be translated for winterization, are invested and key personal items according to their key needs. This is further complicating the provision of aid to collective centers in Donetsk Oblast GCA. It was also mentioned that for GCA, monetizing assistance is still considered as a preferred option where and when it is possible.

Needs of affected population vary from different parts of conflict-affected regions. For example, there is no point to deliver coal to Luhansk NGCA, because this area is rich in coal resources and de facto authorities could provide it based on vulnerabilities. Therefore, the Guidelines is divided into 4 regions: Northern Donbas GCA, Southern Donbas GCA, Luhansk NGCA and Donetsk NGCA.

As a linkage to other main clusters, Food Security Cluster as well as Protection Cluster will be the object of a particular liaison through referral sharing system.

It is important to know the size of clothes and shoes supplied to affected population, because there were cases, when people returned winter jackets not of their size. For this purpose, and as a sample of the best practice, partners may contact director of school to know the size of clothes and shoes for pupils, while in GCA areas partners were implementing cash or voucher programs to better enable the population to select their own preferences.

NRC informed that fuel briquettes production is piloted in GCA now with potential to introduce this crosscutting intersectoral and livelihood activities in NGCA next year. NRC presented the results of their pilot program with participants at the first participation meeting held on the 23<sup>rd</sup> June 2016 (please see the meeting minutes in English and Russian here: [http://sheltercluster.org/sites/default/files/docs/minutes\\_winterisation\\_meeting\\_northern\\_donbas\\_2016-23-06v2.pdf](http://sheltercluster.org/sites/default/files/docs/minutes_winterisation_meeting_northern_donbas_2016-23-06v2.pdf) and [http://sheltercluster.org/sites/default/files/docs/minutes\\_winterisation\\_meeting\\_northern\\_donbas\\_2016-23-06\\_rus.pdf](http://sheltercluster.org/sites/default/files/docs/minutes_winterisation_meeting_northern_donbas_2016-23-06_rus.pdf)). Similarly, assistance can be merged with livelihood activities. It was also mentioned that partners can organise small workshops to produce windows and pay for labour partially with materials.

Further NRC informed about their willingness to share a detailed report related to technical specification of fuel and particularly coal supply.

As participants mentioned, the frequency of shelling is increasing along the contact line, it was précised that the stock for emergency referral should be prioritised during the winterization period. Cluster coordinator informed that a twofold approach are coexisting with each other, they are: a) a contingency plan ruled on inter cluster level and triggered according pre-defined scenario and b) the regular minimum stock for winterisation referral.

**Agenda item 5. Subnational Updates (Cooperation between oblast authorities and partner updates for damage database, next meetings)**

In perspective of the introduction of government energy subsidies for the most vulnerable segment of the population, Donetsk oblast administration –GCA - requested the Shelter Cluster to prepare up to 30 000 leaflets in order to raise awareness of affected population about conditions and access to subsidies.

The leaflets would be able to be produced in October, as Oblast authorities have informed the subnational cluster that new legislation is being developed to support the delivery of this assistance. The Oblast authorities are committed to communicate their coverage of subsidies, so that it can be mapped on the Winterization Matrix with other humanitarian partners to show their joint approach to meeting humanitarian needs

According to Damage Database, there are approximately 20 000 entries, around 11 000 of which were provided initially by Luhansk and Donetsk authorities, other were added during compilation of feedback from partners. In September, Shelter Cluster is going to make extracts from Damage Database to share it on the district level for the last verification foreseeing in assessment cycle.

**Agenda item 6. Updates from Participants**

During the meeting the following updates from Participants were presented:
